# **News to Know**

Dear WJM Parent/Guardian,

As we move into the 5th week of school, we are getting very settled in our routines and procedures, including transportation. On Tuesday, September 28, we will have our first two-hour early dismissal. Please plan for dismissal of students two hours earlier than a regular day. We expect that students will be going home the same way as normal on early dismissal days unless a note is sent to the school stating otherwise. Any changes should be emailed to both secretaries (dgomez@ccboe.com and ddwilliams@ccboe.com) and your child's classroom by 11:00 am on Tuesday. In addition, please make certain to talk to your student(s) :regarding any changes.

12:45 PM - Last pick up for any early dismissals (if someone other than a parent/guardian is picking up a student early, the parent/guardian must send a note identifying who will be picking up the child. The note requires a <u>signature</u> from the parent/guardian. <u>The person who is picking up the child must have a photo ID.)</u>

- We are providing in-house coverage for field trips rather than asking for chaperones.
- Students and staff are permitted to take their masks off when they are outside of the building, including recess.
- CCPS is limiting visitors to the building.
- This year's open house, scheduled for September 28, will be held in a virtual format. Times and links will be sent by classroom teachers on September 27.
- Parent / Guardians picking up their child should not park along the road/parking lots and walk up to the school during car rider dismissal. You must stay in the car rider line.
- Students <u>will not be released from school after 2:50 PM</u> for early dismissal as we are preparing for our dismissal procedures. This allows for a safe and orderly dismissal of all students.

- When visiting the school, we request that you contact us by phone first, if possible, to handle any school business (301-753-1760). Picture ID's, social distancing and facemasks are required for all visitors to Mitchell Elementary School.

#### EARLY DEPARTURE FROM SCHOOL

Dismissal of children during the regular school day (9:00 – 3:30 p.m.) is <u>discouraged</u> because it creates some of the same problems as tardiness & missing out on directions or important parts of a lesson. Occasions do arise, however, when it is necessary for parents to pick children up early. In such cases, please remember the following

- Send an email to Ms. Gomez (<a href="mailto:dgomez@ccboe.com">dgomez@ccboe.com</a>) and Ms. Williams (<a href="mailto:ddwilliams@ccboe.com">ddwilliams@ccboe.com</a>) by 12:00 PM (noon). It is very difficult to ensure a dismissal meets a change if it is not received by noon.
- Please remember students will not be called for early dismissal after 2:45 PM as it could interfere with our regular dismissal procedures.
- Any student being picked up prior to the end of the day will receive an afternoon tardy.

#### CHANGES IN STUDENT'S SCHOOL DEPARTURE ROUTINE

WHAT TO DO?

To ensure your child's safety, we enforce the following:

- Students must have a regular and consistent school dismissal routine.
- If your child's dismissal needs to be different from the regular routine, parents **must** submit a written request each day/occurrence.
- Phone calls will not be permitted as a method to change your child's dismissal routines. We require this notification in writing by 12:00 PM (noon) to both office secretaries, Deanna Gomez (dgomez@ccboe.com) and Deborah Williams (ddwilliams@ccboe.com). Please also include the classroom teacher.
- If for some reason you must send someone else to pick up your child, you <u>MUST</u> send a note each day/occurrence (with your signature) giving the school permission to release your child to that person even if their name is listed as an emergency contact! The person <u>must</u> present a state issued ID before signing out the child.

#### **CCPS COVID-19 PROCEDURES**

CCPS has updated its protocols for the testing of sick students and staff by a school nurse. Students with a known exposure who want to <u>test out</u> of quarantine after **seven days** with a negative COVID-19 test must now visit their doctor, use an outside vendor or test through the Charles County Department of Health. Families may also elect to quarantine their child for **10 days** and return to school <u>without testing</u>. Staff and students may not return to school or school activities until the results of the test are known.
